*01. The proposed development of the steel building and siting of the container would adversely impact on the open and spacious nature of this area which is identified as a local gap. The proposed development would result in a prominent and incongruous development which would have a detrimental impact on the landscape character of the surrounding area. The application is therefore contrary to policies E1, E2 and E3 of the Test Valley Borough Revised Local Plan 2016 and represents an unsustainable form of development, contrary to the 'environmental' dimension of sustainable development, as set out in paragraph 7 of the National Planning Policy Framework. 02. The proposed development, by virtue of its location adjacent to residential properties, will result in the occupiers of neighbouring properties being subject to unacceptable noise levels which, due to the siting and type of development proposed, cannot be adequately mitigated as to ameliorate the impact to an acceptable level. The proposal is therefore contrary to policy E8 of the Test Valley Borough Revised Local Plan 2016. 03. Inadequate information has been submitted in order to demonstrate that the barn building is structurally sound and suitable for conversion without substantial rebuilding. Accordingly, it is considered that the proposed development is contrary to policy LE16 of the Test Valley Borough Revised Local Plan 2016. 04. There is no essential or overriding need for the development to be located in the countryside. The erection of the new buildings and establishment of an employment site is contrary to policies COM2, LE16 and LE17 of the Test Valley Borough Revised Local Plan 2016.
